



No. 931 /RTO, Dt. 20-03-2020


In view of the existing disaster situation for human being all over the world due to spread of Novel Corona Virus (COVID-19) and in pursuance of Order No. 8/GAPG, Dt; 20.03.2020 and 15/CS, Dt: 20.03.2020 of OSD to chief Secretary, COVID-19 management and in exercise of the powers conferred under Rule-63 of the Odisha Motor Vehicle Rules, 1993, I Shri Shubham Saxena, IAS, Collector & District Magistrate, Sambalpur do hereby make the following restrictions in the interest of general public health. It may be noted that these restrictions are purely temporary in nature and suitable modification shall be exercised depending on the situation.

All the public transports including taxis and auto rickshaws on hire inside the city limits of Sambalpur Municipal Corporation area of Sambalpur District will be regulated on alternate days i.e vehicles having odd registration number will ply on odd dates and vehicles having even registration number will ply on even dates. These restrictions will remain in force until further order and will come into force with immediate effect.




