Pursuant to this office Tender Call Notice No.1382/Dt.06.10.2020, 08 (eight) nos of sealed quotations were received in due time by the Tender Committee. The details of the quotation received are:-


1. Call Me Services, Sambalpur

8. Dynamic India, Bhubaneswar

The said quotations were opened in the presence of Purchase Committee Members in the meeting. After scrutiny of the documents it is found that out of the above eight bidder, M/s Unival Forum, Sundargarh and Disha Enterprises, Bhubaneswar have not qualified in technical bid due to non-production of tax clearance certificate, and accordingly a Comparative Statement was prepared and compared at **Annexure-I** among the successful bidder.

After scrutiny of the Comparative Statement, the Committee found that M/s Sri Shakti Solutions, Sambalpur has quoted lowest rate for hiring charges for supply of CCTV Camera compare to other bidder. Hence the committee unanimously decided to select M/s Sri Shakti Solutions, Sambalpur for supply of CCTV Camera. The Committee decided to give him supply order for installation of CCTV Camera in the Exam centres.


