

**(Tender Notice)**

Sealed Tender are invited from interested reputed Travel Agencies/ Tour Operator/ Private Individuals for providing one no. of Petrol (Tiago/Bolt/Celerio) driven vehicle having sitting capacity of minimum 5 including driver, which shall conform to the terms & conditions (Annexure-II) for official use in District Social Welfare Officer, Sambalpur on monthly rent basis.

1. The vehicle must be in road worthy conditions, shall not be more than 3 years old from the date of initial registration and must have valid registration certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, Proof of upto date Tax Payment etc which are mandatory for plying of vehicle.
2. The Driver of the vehicle must have a valid driving license for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behaved, gentle and obedient in nature.
4. A sum of Rs. 5,000/- (Rupees five thousand) only shall be deposited by the intending bidders in shape of account payee Bank Draft drawn in favour of DSWO, Sambalpur and submitting along with the Tender as Security Deposit. After completion of Quotation process, the amount will be refunded to unsuccessful Bidders.
5. The monthly rate of hire charge of quoted separately in the general bid information (Excluding fuel and lubricants) and including Service Taxes.
6. The vehicle must achieve fuel efficiency of 17 KM per Litre.
7. The details of the date and year of the manufacturing of the vehicle, Registration No., Mileage (KM covered per Litre) & Name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the quotation paper as marked in Annexure-III.
8. The Quotation completed in all respect should reach the undersigned on or before 15.11.2022 By 5.00 PM and shall be opened on the next day at 11.30 A.M. on dtd. 16.11.2022.
9. The applicant forms of Quotation containing general bid information and terms & conditions for hiring of vehicles etc will be available with the Office of the District Social Welfare, Sambalpur on payment of Rs. 100/- (Rupees one hundred) only from 10.00 AM to 5.30 PM or can be downloaded from District Website. In case the applicant form is downloaded from the District Website, the applicants have furnished a demand draft of Rs. 100/- towards the cost of the applicants have furnished a demand draft of Rs. 100/- towards the cost of the application along with the application.
10. The Authority reserves the right to cancel the Quotation without assigning any reason thereof.



TERMS & CONDITIONS FOR HIRING OF VEHICLE

The following terms & conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

1. The hired vehicles, during period of contract, shall have all necessary valid MV documents such as: valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, Proof of up to date tax payment etc. and D.L. of the driver available all the times. The Department/ Office hiring the vehicle shall not be responsible for any damage/ loss caused to hired vehicles or loss of life/ injury made to any person or damages to any property on account of use of hired vehicle any manner whatsoever. The hired shall be responsible for all such litigation.
2. The hired charges to be paid for monthly basis is final but does not include cost of diesel, which is to be paid separately basing on actual consumption and lubricants as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, Lubricating oil of Engine, Gear Box & differential Coolant, Tyres & Tubes, Battery etc will be borne by the bidder.
3. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
4. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/bidder.
5. In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.
6. The Vehicles shall report for duty for minimum of 25 days in a month.
7. In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
8. Monthly hiring charges and reimbursement towards cost of Petrol (as per actual) and lubricant (as per Govt. norms) of selected bidder will be paid in every succeeding months, as per as possible within fifteen days of the submission of bills by the service provider and no advance payment will be made.
9. The vehicle shall not be more than 3 years Old from the initial registration and also in good condition during the period of contract.
10. If the services are found to be dissatisfactory, termination of the hiring vehicle will be made after 2 times reminder of the undersigned.
11. In case the service provider intends to withdraw the services of his vehicles and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
12. If the bidder violates any of the terms and conditions of contract, Government shall forfeit the entire amount of security deposit.
