WHO CAN PARTICIPATE IN THE EOI

The following is the eligibility criteria for participating in the Eoi

- 1) The Service Provider should be a Govt. / Non Govt. entity registered as a company or proprietorship or a society under the applicable laws in India. 3. TERMS AND CONDITIONS FOR PROVIDING MANPOWER BY SERVICE PROVIDER.

- i. The personnel engage by the Service Provider cannot claim to a regular appointment at any time in the Sambalpur District/ F & ARD Department.
- ii. During the tenure of engagement, the manpower provided by the Service Provider shall abide by the Rules, regulations, conditions prescribed by the Farm Manager.
- iii. During the period of engagement, the personnel provided by the service provider shall be required to work and attend the duties as may be assigned by the SAFDO.
- iv. The personnel shall be entitled to a maximum of a 10 days of leave in a year with prior approval from the SAFDO. Any unauthorised absence shall attract proportionate deduction from the consolidated monthly remuneration.
- v. In the event of unauthorised absence or any other misconduct by the personal deployed by the Service Provider such personal shall immediately be replaced.
