

## TERMS AND CONDITIONS


01. The tenderer should be a Registered Firm under GST Act.

03. The delivery of the items should be made in the Athletic Society, VIMSAR, Burla, Sambalpur in good condition. Any conditional Tender will not be accepted
04. The tender submitted by the firms should be properly page marked.
05. No advance payment will be made against execution of order. Payment will be released only after successful supply of the ordered items.
06. The rates should be valid for one year from the date of approval..
07. The exemption of Tender Cost or EMD will be made as per the rule of Govt. Supporting documents in this context should be enclosed in the tender for verification.
08. Original documents may be produced for verification if asked for.
09. If any information/documents furnished by the tenderers with the tender paper are found to be misleading or in correct, at any stage their tenders will be cancelled.




