

- 4) Rate to be quoted is per unit of items which is inclusive of all taxes and delivery at DSSO, Sambalpur.
- 5) The firm must have prior experience in dealing with such items.
- 6) Payment shall be made after complete supply of the materials as per the specification after due verification of the Purchase Committee.
- 7) Attested copies of CGST/SGST/ISO Registration No or Clearance Certificate valid up to March, 2022 should be furnished with the Tender Paper.


