
Sealed quotations in plain paper are invited from intending bidders for auction Sale of Govt Vehicle (Ambasadar Car) bearing Regd.No.OR-05-G-8863 on as and when basis. The Vehicle can be inspected by the intending bidder from 20.02.2023 to 28.02.2023 within the office hours from 10 AM to 5 PM. The intending bidder shall submit an application in the prescribed proforma in sealed cover quoting the rate along with security deposit of Rs. 1000/- (One thousand) only in shape of Bank Draft/Bankers Cheque in favour of Joint Director , AH&VS (O) Chiplima Payble at State Bank of India , Goshal Branch, Dist-Sambalpur on or before 01.03.2023 and the same will be opened on the same date by 11.30 AM in the Office Chamber of Joint Director , AH&VS (O) Chiplima in the presence of the bidder or their authorised agent. The Highest bidder will deposit 25% of the total bid amount on the spot with in 4 PM on the same date and the balance amount is to be deposited within 7 days upto 5 P.M. The selected bidder have to deposit 18 % GST on the bid amount within that 7 days. After deposit of the entire bid amount and the GST the vehicle must be removed from the site by the successful bidder within 24 hours. It will be the responsibility of the successful bidder to look after the vehicle at his own expenses and the Joint Director , AH&VS (O) Chiplima will not be responsible for any damage done by way of pilferage or otherwise and no claim on this account shall be entertained . In case vehicle is not lifted within the above date , ground rent @ 10% of the bid amount for each day of delay will be charged. In case the ground rent exceeds the bid amount deposited , the purchaser will cease to have right over the auctioned vehicle and the bid value deposited will be adjusted towards ground rent and the vehicle will become the absolute property of the Joint Director , AH&VS (O) Chiplima.
