1. The tenderer should be a registered firm under the GST Act.
2. The quoted rates should be inclusive of all taxes except GST. The GST charges should be clearly mentioned separately.
3. The delivery of the items should be made in the Central store of this Hospital in good condition.
4. Any conditional Tender will not be accepted.
5. The rates will be valid for one year from the date of finalization of the Tender.
6. The selection of items may be followed on selection of samples whenever necessary.
7. Original documents may be produced for verification if asked for.
8. If any information/documents furnished by the bidders with the tender papers are found to be misleading or incorrect at any stage, their tenders will be cancelled.
9. The bidders should mention the percentage of discount of the various manufacturers clearly. The selection may be made on the basis of the requirement of the items by the hospital.
10. The average turnover of the bidder should not be less than 03 (three) crores per year for the last three financial years i.e.2019-20,2020-21 and 2021-22..
11. Authorization of the Principal firm/ manufacturer basing to this office Tender Call Notice must be attached.
12. An undertaking in a stamp paper of Rs.10/- or above that " Incase of non payment of our pending bills/ supplied items in time due to non available of allotment on the appropriate head or due to any unavoidable circumstances by the office, I/we will not stop supply of any order item for the interest of patients care."
13. An undertaking in a stamp paper of Rs.10/- or above that "My/Our firm is not blacklisted by any office of Odisha Govt/ Central Govt."
14. The bidders should must enclose the product list along with the M.R.P. of the manufactures which has been quoted in the Tender Call Notice.

- (xi) Turn over certificate for the last 03 (three) financial years i.e.2019-20, 2020-21 and 2021-22.from the Chartered Accountant.


