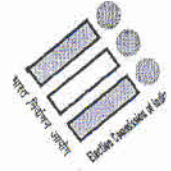

Whereas, it is to intimate that, the Expenditure Observer, 3-Sambalpur PC made the following comments during 1<sup>st</sup> inspection of the expenditure observation register on 15.04.2019.

1. From the Part-A of the register it is found that as per SoR (Page No. 5 to 8), there is understatement of expenditure to the tune of Rs. 62,954/- (Details are reflected in Annexure-1).
2. Vouchers in some cases are without important details about payee. Without such details the vouchers cannot be accepted.
3. Many entries are made in Part-B without mentioning nature of expenditure in Col. No.-7. It appears to be violation of section-77 of the R.P. Act-1951.
4. Some persons have been paid more than Rs. 10,000/- in cash.
5. As on 13.04.2019 as declared in this part which is clear violation of ECI instruction.
6. It is ascertained from the Part-C of the register that the candidate has withdrawn Rs. 20,00,000/- on a single day without necessity. A clarification is called for.

You are therefore, requested to go through the above observations and reconcile by 16.04.2019.

Whereas, it is to intimate that, the Expenditure Observer, 3-Sambalpur PC made the following comments during 3<sup>rd</sup> inspection of the expenditure observation register on 20.04.2019.

1. The candidate has declared expenses towards printing of election materials of Rs. 6,24,000.00 with the supporting MR No: 309, dtd. 15.04.2019 and Bill No. 289,290, 291, dtd. 14.04.2019 from the printer M/s Impressions, B/5, Industrial Estate, Baraipali, Sambalpur, Ph: 943132809, 9437055971. However, it is verified and found that the said printer has not intimated to the DEO.
2. "In Part A of the Candidate's Register as per SoR (Page no. 10 to 15) with regard to 3 different events on account of Rs. 23,300/- has been understated. In Part C of the Candidate's Register, an amount of Rs. 27,50,000/- has been paid for 6 persons vide Cheque No. 001258, 001259, 001261, 001264, 001265 & 391151 as payment for "Advance for Booth expenses". However no details of goods/services for this payment in details has been submitted. It appears to be gross violation of Section 77 of the RP Act, 1951".

You are therefore, requested to go through the above observations and reconcile by 23.04.2019.

Respected Sir,

With reference to your letters' cited above I submit here with submit my compliance report on the different points as raised there in for favor of disposal.

**i. Inspection of Expenditure observation register dtd 15/04/2019.**

1. Agreed to the observation made. The understated amount of Rs 62954/- is reflected accordingly in the register of Election Expenditure.
2. All the vouchers have been prepared henceforth with details of Payee. In every cases ID proof of payee has been attached with ~~ve~~ serially numbered.
3. It has been complied. Part -B of register maintained properly.
4. Due care has been made not to make any cash payment exceeding Rs 10000/- hence forth.
5. As on 13/04/2019 one cash payment exceeding Rs 10000/- has been made erroneously. In future this will be guarded against and no such transaction will be made.
6. A number of payment was to be made to the different persons of my constituency relating to election matter as such, the said sum of Rs. 2000000/- was withdrawn. However, when the irregularity of keeping such an amount was pointed by the learned Observer, the residual amount of Rs. 18,13,000/- was immediately credited in the designated branch of SBI on dtd.15.04.2019 as 14.04.2019 was Sunday and sum amount out of the said amount was spent on dtd.12.04.2019 and 13.04.2019 relating to election matter.
