Whereas, it is to intimate that, the Expenditure Observer, 3-Sambalpur PC made the following comments during inspection of the Election expenditure register on 16.04.2019.

- 1. For all the expenses shown in Part-A there is no matching entries in Part- B & C.
- 2. Rs. 900/- is understated as per SOR.
- 3. An amount of Rs. 35,000/- has been shown as expenditure made in Part-c, with two cheques (self). But these cash receipts have not been declared in Part-B as of now 6.00 PM on 16.04.2019.
- 4. The register is incomplete as above. It appears to be violation of provision of Section-77 of R.P. Act-1951.
- 5. The entries in Part- C has not been made in daily basis.
- 6. Candidate has withdrawn from Bank amount Rs. 25,000/- on 16.04.2019 of mention the nature of expenditure as 'Security Deposits'. This is not tallying with Part-A.
- 7. The register is not mentioned in the manner prescribed.

You are therefore, requested to go through the above observations made by Expenditure Observer during the inspection of Election Expenditure Register produced by your agents. You are required to comply the above objection in writing on 18.04.2019.
