ORDER

In pursuance of the Odisha Sub-Ordinate staff Selection Commission letter No. IIE-53/2018/188(C) / OSSSC dated 01.06.2019 & Letter No. IIE-53/2018/1075(C) / OSSSC dated 12/12/2018 & D.O. No. 174/WCD Dtd. 19.09.2016 of Commissioner-cum-Secretary to Govt. , WCD & MS , Odisha, Bhubaneswar, the following candidate is provisionally appointed as supervisor on Contractual Appointment in the consolidated pay Rs. 16880/- P.M under PB-2. This is in accordance with Odisha Group-C and Group-D post (Contractual Appointment Rules, 2013). During the period of contractual appointment they shall draw monthly remuneration as per G.A. Department Notification No. GAD-SC-Rules-0037-2017-19569/Gen. dated 12.09.2017. Appointment is contractual initially to be guided by the Group-C and Group-D post (Contractual Appointment) Rules, 2013 notified vide G.A. Deptt. Notification No. GAD-SC-Rules-0009-2013-32010/Gen. dated 12.11.2013. Their contractual services shall be renewed every year basing on their satisfactory performances and can be regularized on completion of 06 years of continuous service.

She is entitled for leave under the provision of Odisha Leave Rules, 1966.

Besides she shall be enrolled under the New Pension Scheme Contained under appointment made under Rules-9(1) of the said rule.

The appointment is purely temporary and can be terminated at any time without notice or assigning any reason thereof.

She should join in the post within 15 days from the date of receipt of her Order in the ICDS projects as noted against her, failing which her appointment stand automatically cancelled and she will not claim for any further appointment in this establishment.

1. No TA/DA is admissible to join in the place posting.
2. An undertaking to be submitted at the time of joining to the effect that she will serve anywhere in the District and will not represent for transfer or deputation to any other District.
3. Candidate is required to produce the following documents at the time of joining.
 - a) Medical fitness certificate from a Government registered medical officer not below the rank of an Assistant Surgeon.
 - b) Two passport size photographs duly attested by a Gazetted Officer.
 - c) Two characters certificate issued by Gazetted Officer.
 - d) Educational certificate showing the date of birth.
 - e) The married appointees should furnish a declaration to the effect that he/she has not more than one legally married spouse living.
 - f) Caste certificate in original in case of ST and SC candidates.
 - g) SEBC certificate in original issued within one year in case of SEBC candidates.
