The qualified candidates are required to appear in the Computer Test (Practical) and Type test (on Computer) on 13.02.2020 (Thursday) at 9.00 A.M onwards at Civil Courts premises, Sambalpur.

The Computer Test (Practical) and Type test (on Computer) shall carry 50 marks each and of one hour and 25 minutes duration respectively. In Computer Test (Practical) candidate's proficiency relating to matters like "Text formatting of the paragraph, insertion of table, skill to print and save, file transfer, web site searching/browsing and downloading email, use of pen-drive and other software etc. and programmes of accounting will be tested. In Type Test (On Computer) candidate shall be required to type a passage of 400 words in English and 300 words in Odia. The successful candidates of Computer Test (Practical) and Type test (on Computer) are to appear in Viva voce test in the afternoon onwards.

The Intimation Letters have been issued to the qualified candidates.
