The Viva-voce Test for the candidates, those who will qualify in the Practical Test, will be held at 2.00 P.M., in the Civil Courts premises, Sambalpur, on same day i.e. on 24.1.2021 (Sunday).

The candidates appearing in the aforesaid tests are required to come to the venue of examination with **Face Mask, handy Hand Sanitizer** and to maintain **Social Distancing** to contain spread of **COVID-19 pandemic**.

The candidates, who have not received the Intimation Letters for the **Practical Test in Technical Knowledge in Survey & Settlement** sent by Post, may contact the Registrar, Civil Courts, Sambalpur during **10.30 A.M. to 12.30 P.M. on 22.1.2021** for obtaining Duplicate Intimation Letters. For obtaining Duplicate Intimation Letters, such candidates are required to produce their Admit Cards issued to them at the time of written examination and Aadhaar Cards.

The candidates are required to produce the following documents at the time of the concerned tests for verification:-

Original Documents to be produced at the time of Practical Test in Technical Knowledge in Survey & Settlement:

- (i) Admit Card issued at the time of written examination.
- (ii) Intimation Letter issued for Practical Test in Technical Knowledge in Survey & Settlement.
- (iii) Original Aadhaar Card.

Original Documents to be produced at the time of Viva-voce Test for the candidates those who will qualify in the Practical Test in Technical Knowledge in Survey & Settlement:

- (i) Certificate and Mark-sheet of Matriculation or equivalent Examination of a recognised Board.

- (ii) Certificate of Revenue Inspector Training.
- (iii) Certificate showing passing of Odia at least ME standard from a recognised institute in case of candidates having no Odia subject in their study curriculum.
- (iv) Medical certificate issued by the competent Medical Authority/Board in case of Physically/Orthopaedically handicapped candidates.
- (v) Certificate/Identity Card in case of Sports person and Ex-serviceman.

The candidates shall report at the venue of examination at **8.30 A.M.** on the scheduled date for Practical Test in Technical Knowledge in Survey & Settlement.

No TA/DA shall be admissible to the candidates for appearing the aforesaid test(s).
