

2. The selected candidates are directed to produce all original certificates and a set of Xerox copy of their educational qualification & other eligibility during the time of joining, failing which their joining will not be accepted.
3. This daily wage engagement will come into force from the date of their actual joining and the engagement will be valid till functioning of the COVID Hospital, VIMSAR, Burla or received any direction from the Govt. whichever is earlier. The duration may be extended or curtailed if situation so warrants.
4. The engagement is purely temporary and can be terminated at any point of time without assigning any reason thereof.
5. The selected candidates will submit an affidavit on Rs. 10 or above stamp paper to the effect that :-
 - a) They will not claim any Government post/ regular appointment in future.
 - b) They will neither claim any financial benefit other that the amount which is fixed above, nor Govt. accommodation.
 - c) In case of need they might be deputed to any other station apart from VIMSAR, Burla considering the situation of the COVID-19 pandemic.
6. The undersigned reserves the right to terminate their services in case of misconduct or their performance is not satisfactory.
7. In case of any dispute arising out of this engagement, the decision of the undersigned shall be final.
