As approved vide letter No. 14701dt. 21.06.2023 of the Government in Health & Family Welfare Department, Odisha, 80 posts of Nursing Officer will be filled up in VIMSAR, Burla by engaging Retired Government / Private Nursing Personnel. The selection of Retired Nursing Officers will be done as per the guideline issued by the Government in General Administration Department, Odisha vide Resolution No. 23750 dt. 27.08.2014 and Office Memorandum No. 24533 dt. 29.09.2022 of the Government in Finance Department, odisha.


Application for engagement of Nursing Officer on consolidated remuneration is invited herewith from the interested candidates in prescribed format alongwith required documents as in detailed below in hard copy through Regd. Post/ courier/ speed post only addressed to the Superintendent, VIMSAR, Burla by 21.08.2023 to 05.09.2023 on 5.00PM. Applications received after scheduled date & time will not be accepted.

**TERMS & CONDITIONS:**

1. Nursing Officers who have retired from Government / Private Sector on attaining the age of superannuation and below the age of 65 years having good service records and physically fit shall be eligible to be considered for re-engagement.
2. The re-engagement is purely temporary and can be terminated at any time by the appointing authority due to unsatisfactory performance of any of the re-engaged Nursing Officer by giving one month notice or till the posts are filled up by regular recruitment. On the contrary, if any re-engaged officer desires to resign he/she shall do so by giving one month written notice to the competent authority. The re-engaged employees will be assigned the duties as & when required by the authority from time to time.
3. Nursing Officers against whom departmental proceedings or criminal cases are contemplated / pending or who have been penalized for misconduct during the period of preceding five years will not be eligible for consideration.
4. The re-engagement shall be made initially for a period of one year and can be extended for subsequent period of three years with spells of one year each subject to satisfactory performance up to a total period of four years not beyond the age of sixty -five years of age in any case or till the posts are filled up by regular recruitment whichever is earlier.
5. Consolidated remuneration entitled for the posts will be in accordance to the finance Department office memorandum No. 24533 dt. 29.09.2022.
6. Re-engaged officers shall be governed by the provisions of Odisha Government Servants conduct Rules, 1957, and shall be liable to be proceeded against for their misconduct, omission and commissions as per the provision under the odisha pension Rules, 1992.
