





## TERMS AND CONDITIONS

1. Sealed quotations from the intending bidders will be received by registered post / courier service by the undersigned on or before 21.02.2024 up to 11.00 AM (No hand delivery is permitted). The sealed tender papers will not be acceptable after the due date and time. The bidders must super scribe the sealed cover as QUOTATION FOR ACTION SALE OF MANGO OF BLN LOISINGHA / GUDVELLA.
2. Quotation should be accompanied with earnest money deposit in the shape of Demand draft / banker's cheque drawn in favour of Deputy Director of Horticulture, Balangir for BLN Loisingha / Gudvella farm payable at S.B.I Balangir. Quotation without Bank Draft / Banker's cheque will be rejected. Deposit in no other form is acceptable, the D.D. / Banker's Cheque amount shall be adjusted towards the sale value of the successful bidders and all other cases shall be refunded to the parties concerned, after the conclusion of tender process.
3. The sealed quotations received in due date will be opened as per scheduled mentioned in the tender call notice for Auction of Mango in presence of the auction committee and the bidders or their authorized representatives in the office of the Deputy Director of Horticulture Balangir on dated 21.02.2024 time 1.00 P.M.
4. In all the cases sale shall be confirmed by the DDH only after the full amount along with the security money is realized. Security money to the tune of 10% of sale value shall be deposited by the party in shape of hard cash on the same day of auction. The security money shall be released after the harvesting period is over i.e. after July-2024.
5. The highest bidder should deposit the sale value in full on the same day, failure of which will entail forfeiture of his EMD and on that event the other renderers shall be considered one after the other in decreasing order of their bid provided their offer more than the upset price and is acceptable otherwise.
6. The Farm In-charge / Asst. Director of Horticulture shall issue work order as the case may be only after confirmation of the sale by the DDH.
7. All appeal in the matter of any dispute shall lie only with the Director of Horticulture, Odisha, Bhubaneswar whose decision shall be final and binding on all parties

8. Before issue of work order an agreement shall be executed by the Farm In-charge with the successful tenderer incorporating all terms and conditions of sale in a standard format to be approved by the DDH, Balangir.
9. The authority is not responsible for any damage or shortfall due to natural calamities or any reason.
10. The intending parties may visit the farm on any working day of the farm between 9 AM to 5 PM, obtaining necessary permission from the Farm In-charge before submission of the quotations.
11. The highest bidder has to furnish an undertaking to the effect that he will not injure or damage to the existing plants and other plants too during harvesting of fruits. He is liable to give compensation if any injury or damage is caused to the plants and nursery. The injury or damage compensation is to be fixed by the office / Farm In-charge and decision of the Deputy Director of Horticulture is final. The successful bidder will be allowed to harvest the fruits of the specified blocks.
12. The money receipt of the tender paper in original is to be attached with the tender paper.
13. The authority reserves the right to reject any or all quotations without assigning any reason thereof.
14. The record on total quantity harvested is to be maintained and to be submitted to the respective AHO of the farm.
15. E.M.D to be deposited is Rs. 500/- for BLN Loisingha & Rs.1000/- for BLN Gudvella.
16. If any authority feels that the bid value quoted is lower than the upset price, then the committee may negotiate with the bidders.
17. Working period to be specified by the Deputy Director of Horticulture / AHO concern is final.
