TENDER FOR HIRING COURIER AGENCY FOR SPUTUM TRANSPORTATION

INSTRUCTION TO TENDERERS

1. Sealed tenders are invited from **Registered Courier / Carrier Transporter Agencies / Individual/ for Sputum Transportation** for engagement by the CDM&PHO-Cum-District Mission Director ,Sambalpur on **Per Visit Basis**.
2. The interested bidder may download the tender document from the website : www.sambalpur.nic.in
3. The tender will have to be submitted in two parts i.e. **Technical Bid (Cover-A)** and **Financial Bid (Cover-B)**. The formats & documents to be submitted in technical & financial bid are mentioned in the tender document. The bidders should submit their **technical** and **financial** bid **separately** in **two envelopes** and these two envelopes should be put into **another cover envelop** super scribed as "**Tender for hiring of Registered Courier/Carrier Transporter Agency/Individual for Sputum Transportation & the advertisement reference no**". The Technical & Financial Bid envelopes should be clearly marked as **Technical Bid & Financial Bid** on the top of the relevant envelopes. 4. The tender should reach the office of the CDM&PHO-Cum DMD NHM, sambalpur by **18/03/2024(5.00 P.M) through Speed post, Registered post and courier only**. The tenders will be opened at **11.00 A.M on 19/03/2024 in the office chamber of CDM & PHO,Sambalpur**.
5. The financial bid of those tenders shall be opened whose technical bid are found to be qualified.

Eligibility Criteria

1. The tender must be accompanied by **EMD of Rs.10, 000/- in technical bid** by way of demand draft, drawn on any Nationalized / Scheduled Bank in favor of, **ZSS Non NRHM Account** payable Sambalpur. Tenders not accompanied by earnest money will not be considered. EMD of unsuccessful tenders will be returned without interest on finalization of bid. EMD of successful tenders will be retained as performance security & will be refunded on successful completion of the job without interest after the terms of the agreement.
2. The agency should have a valid **GST registration & PAN**.
3. Income tax return copy for FY **2020-21,2021-22 and 2022-23**
4. **GST Registration certificate**.
5. The agency should have Transported Sputum for Govt. Hospitals, or any Private Hospitals, Clinics etc. during the last three years. Priority will be given if the agency has government experience (If Any).

TERMS AND CONDITIONS FOR SPUTUM TRANSPORTATION.

1. The Sputum's are to be collected from Households/Non DMC PHIs to DMC and DMCs to CBNAAT Site/IRL Site.
2. The agencies are to Maintain Cold Chain from the time of Collection of Sputum Transportation to the DMC's and From DMC's To the CBNAAT/IRL Site.
3. The agency needs to Transport Sample In 3-Layer Packing as per the Norm of CTD Guidelines.
4. The Samples are to be Transported and submitted to DMC's/CBNAAT Site/IRL Site with 24 hours from the time of collection.
5. The samples needs carried with Proper and Clear Labeling (Name/ ID/Type of Sample/Type of Test).
6. Any other additional cost incurred other than the approved rate will be borne by the agency during the transportation.
7. Necessary apparatus or equipment's required for transportation will be purchased by the agency as no such things will be provided by the Office.
8. The agency will be whole some responsible for breakage and leakage of Sputum's during the period of transportation, in such case no payments will get count.
9. The Sputum Carriers by the agency needs to carry sputum from Households, Non DMC PHI to DMC and DMC to CBNAAT Site /IRLS Site (within District) and Outside district (If Required).
10. The period of contract shall initially be for one year with effect from the date of signing of contract. Which can be extended upto 3 years on satisfactory performance and mutually agreed by both parties.
11. During the course of transportation the Agency will bear the total fuel/Oil and any other Charges, In such case no fuel/Oil and any Other Charges will Get Reimbursed during the Claim Of bills.
12. If any discrepancy to be found in samples and requisitions, the receiver end i.e., DMC or CBNAAT/IRL Site may reject the sample, If such are to be found damaged due to improper Transportation.
13. The agency shall provide substitute in case the employee/Carrier is unable to attend the work on any date / time as no single day the sputum transportation should get obstruct.

14. In case of any emergency or when required, the Agency shall provide Employee/Carriers for Sputum Collection and Transportation.
15. It is the sole discretion of CDM&PHO Cum DMD, NHM,Sambalpur to extend the period of the contract order beyond the agreement period or terminate the contract prematurely on the ground of unsatisfactory services, disobedience of orders, negligence in duty and unruly behavior, if noticed in duty.
16. **Period of Service: One year** from the date of signing of contract .Which may be renewed maximum up to 3 years based on satisfactory performance.
17. **Termination:** CDM & PHO-cum-DMD, NHM Sambalpur shall have the discretion to terminate agreement /work order at any time by giving one month notice whereupon the agency will immediately cease the provision of the Services and submit a bill for costs incurred to provide the contracted services to the date of termination.
18. **Payment:** Payment shall be made on monthly basis after submission of bill along with the daily Collection Chart and duty slip signed by the designated authority of the CDM&PHO Cum DMD sambalpur, NHM.
