The Quotation completed in all respect should be submitted to the undersigned in the drop Box of Establishment Section of Collectorate, Sambalpur on or before 23.09.2024 by 3.00 P.M and shall be opened on the same day at 4.00 P.M in presence of the bidder or their Authorized representatives in the Chamber of Additional District Magistrate, Sambalpur.
4. After completion of the examination the selected bidder should submit 02 sets of CCTV footage of all centers within 02 days.
5. The authority reserves the right to cancel the bid without assigning any reason thereof.
6. The authority reserves the right to increase or decrease the number of CCTV Camera.
7. As examinations are conducted at Sambalpur zone frequently, the rate of tender that will be finalized on 23.09.2024 will be valid for a period of one year. The extension of validity period may be granted by competent authority if required.
8. The successful bidder will install all the CCTV in the examination centers before 7 days of commencement of exam and submit a certificate of installation from the concerned Centre Supervisor/ Center Superintendent of the examination centers.
9. On violation of the above terms & conditions or any defects found in CCTV recording and in recording copy, an amount of 20% of the total value of the bid will be deducted from the payment of the successful bidder.
