The Expression of Interest (EoI) are invited from the intending bidders/reputed firms/empanelled firms having GST clearance for supply & installation of 66 nos. of Hoardings size 20 ft X 10 ft of iron frame stand as per detailed specification (Star media flex including printing with rectangular iron frame & mounting on hoarding Model Estimate communicated vide letter No.26173/ dt.23.08.2021 of Chief Engineer Agril. is Enclosed) for **7 nos** of cluster i.e **Rampella-I** of Rengali & Dhankauda Blocks, **Rampella-II** of Rengali Block, **Jankadihi cluster** of Kuchinda & Bamra Blocks, **Saida cluster** of Kuchinda & Kuchinda NAC, **Nuagaon cluster** of Kuchinda & Jamankira Blocks, **Chandinimal cluster** of Kuchinda & Jamankira blocks, **Budulapali & Manapali cluster** of Kuchinda & Jamankira blocks (for 2022-23, 2023-24 & 2024-25) & 1 no. of cluster in Goinpura of Maneswar block (2024-25) of Sambalpur district under the scheme CDP-MLIP during 2024-25 (Funds of 2022-23, 2023-24 & 2024-25) by the Chief District Agriculture Officer, Sambalpur.

The undersigned reserves the right to reject the quotation in part or full without assigning any reason thereof. Quotations received in incomplete form will be rejected. Postal delay if any shall not be considered to accept.

**Terms & Conditions:**

1. The bidders/ firms must have valid GST registration certificate with latest GST return, PAN card & Identity proof copy with quotation.
2. The agency/ agencies need to submit the copies of IT return for 2022-23 & 2023-24.
3. The agency/ firm should not be black listed.
4. If the quoted price of more than one bidders/firm found to be equal, the committee reserves the right to select & take the final decision on it or by lottery.
5. For any further queries/ information, contact the office of the Chief District Agriculture Officer, Sambalpur during working hours.
6. The undersigned reserves the right to accept or reject any or all the quotation(s), without assigning any reason thereof.
7. Preference will be given to State Level empanelled agency of different Government organisation having past experience for similar assignments in Agriculture & Farmers'Empowerment Department.

Payment will made after supply and installation of the hoarding and submission of signed challan copies by Block Agriculture Officer/ Assistant Agriculture Officer & Assistant Agriculture Engineer of concerned block. The GPS photographs are to be submitted after installation of hoardings along with bills.
9. The bidders/firms should deliver the items at installation point without charging extra cost towards transportation.
