(C) Deposit of Earnest Money : The successful Tenderers will be required to deposit an amount of 25% of the bid value of goods as earnest money deposit within 07 (Seven) days from the date of receipt of letter for communicating acceptance of his offer.

Balance of the value shall be paid by the buyer to the Divisional Officer or his representative after acceptance of bid within the time limit as communicated.

(D) Penalty : (i) In case of bidders failure to deposit earnest money within the time limit prescribed above the caution money deposited by the bidder will stand forfeited.

(ii) Similarly failure to deposit the balance amount of bid money within the prescribed time limit will entitle the forfeiture of the earnest money deposited by the Bidder, in all such case the name of the defaulting tenderer shall be circulated to other Division so that such Bidders are debarred from bidding in future.

(E) Acceptance of the bid : The acceptance of the tender will be conveyed by the owner in writing to the successful bidder normally in a month's time from the date of opening of tenders, but any delay in the matter shall not invalidate the tender or the responsibility on the bidders.

(F) Removal of Materials : (i) Material shall be removed by the bidder within the prescribed time for the purpose which will be communicated at the time of acceptance of the bid after full deposit of the bid amount is made.

(ii) As soon as the full amount of bid money is paid by the buyer he would acquire his requisites permission etc. from the owner and it will be his responsibility to look after the stores, at his own expenses and department will not be responsible for any damage done by the way of pilferage or any other unforeseen calamity and no claim on this account will be entertained.
