



General Instruction for submission of Quotation:

The tender will be two parts i.e. Technical Bid (Cover-A) and Financial Bid (Cover-B). The bidders should submit their technical and financial bid separately in two separate envelopes and those two envelopes be inserted in a third envelope superscripted with Quotation for **“Supply of Design of Packaging Materials for Take Home Ration (THR) under MukhyamantriSampoornaPusthiYojana (MSPY)”**. The Technical & Financial Bid should be clearly specified as Technical Bid & Financial Bid on the top of the relevant envelopes. The EMD & Cost of Tender Paper should be submitted in the envelope containing Technical Bid along with the relevant documents as specified in the quotation. The bid should be addressed to:

TERMS AND CONDITIONS

1. TECHNICAL BID

Technical bid should contain the following in Annexure-1

1. Name of the Firms/ Printing Press

3. Registration certificate of firm

5. Original Money receipt
6. The EMD amount of Rs. 24000/- (Rupees Twenty Four thousand) only may be submitted in shape of DD/BD/FD favouring DSWO, Sambalpur.
7. Return of EMD will be made to the unsuccessful bidder soon after completion of the tender process after obtaining requisition from the concerned bidder. The successful bidder may demand the EMD amount after successful completion of the work as per the terms and conditions of the tender.
8. The firm must have valid DIC Registration
9. The firm must submit Income Tax registration and update IT returns for last preceding three years.
10. The firm must attach attested copies of GST registration and clearance .
11. A sample copy of materials of each specification to be used for printing shall be enclosed.
12. Must have two years of Experience certificate from any Govt./Private/PSU etc.
13. All documents submitted should be duly signed by the authorised signatory of the Organisation.
14. The firm must have submit a Self-declaration of **“ NOT BLACK LISTED ”**(Annexure-3)

2. FINANCIAL BID


The financial bid should contain the price of each specified items as per Type of THR /Beneficiaries type/Quantity/Dimension/bottom seal length etc. The unit cost of each item to be printed should be mentioned in the prescribed format in Annexure-2 of the tender paper.

The tender has been invited under two bid system i.e. Technical Bid and Financial Bid. The interested agencies are advised to submit two separate sealed envelopes super scribing "Technical Bid" and "Financial Bid".

3. Both Sealed envelopes should be kept in a third sealed envelope Super Scribing " **TENDER FOR PRINTING& SUPPLY OF PACKAGING MATEIALS FOR TAKE HOME RATION(THR) PROVIDED UNDER MUKHYA MANTRI SAMPOORNA PUSHTI YOJANA(MSPY)"**FOR SAMBALPUR DISTRICT DURING THE YEAR 2024-25.
4. The successful tenderers shall be required to print and supply the packaging materials for Take Home Ration (THR) provided under Mukhya Mantri Sampoorna Pusti Yojana (MSPY) only to 18 Nos. of THR produced unit of District as per the quantity required /Suggested by this office.
5. The tenderer shall carefully go through all the terms and conditions of the tender documents and submit the tender paper correctly. The tender paper should be filled in properly and legibly without any correction/ overwriting and must be typed copy/ computer copy. No opportunity shall be given to the tenderer to rectify or amend any defect at the time of scrutiny. The rate should be written both in words and in figures in the tender schedule. The rate quoted should be final and the tenderer shall not be allowed to change the same under any circumstances and it should be valid for one year from the date of opening of the tender.
6. Earnest Money to the tune of **Rs. 24000/- (Rupees Twenty Four thousand)** only in shape of **Demand Draft in favour of District Social Welfare Officer, Sambalpur** shall be furnished along with tender. Tenders without Earnest Money will be liable for rejection. EMD in the form of Cash/ Cheque shall not be accepted. No tenderer shall be allowed to withdraw his tender/ Earnest Money Deposit until the tender is finalised. In case successful tenderer refused to supply & printing the materials after acceptance of his tender, the Earnest Money deposited by him will be liable for forfeited .
7. The price quoted should be inclusive of all taxes, Transportation, Labour cost etc. The bidder whose total quoted price will be less as compared to the quoted price of other bidders will be considered as lowest (L-1) bidder and so on.
8. The cost of each unit shall valid for one year from the date of finalisation of the Bid/Issue of working order.
9. In case of disputes about the quality/Quantity /Delay in supply , the Collector or his authorised representatives will cause an enquiry and take suitable action including debarment against the supplier.
10. The suppliers shall have to submit the claim bills directly to the DSWO, Sambalpur for their payment after delivery of the Items to 18 Nos. of THR units of the District .Tender received after the stipulated date and time or without sample shall be liable for rejection.


