- 1.1 Sealed tenders will be received by Dated 26.05.2025 for Supply of Drugs & Consumables under NPCBVI for the year 2025-26 & 2026-27 up to 01.00 PM (On working days only) by the CDM&PHO, Sambalpur in the office of the Chief District Medical & Public Health Officer, Sambalpur. Any tender received after the due date & time will be rejected & returned to the sender unopened. **The tender paper will be received through Regd. Post / Speed Post/ Courier services only.**
- 1.2 The bidder(s) are to submit their tenders in **separate** sealed covered envelopes for **technical bid** and **commercial bid** by superscribing **Cover "A" (Technical Bid) & Cover "B" (Price Bid)** and both the sealed covers should be put into a **third outer Cover**, which should be superscribed as **"Tender of Drugs and Consumables under NPCBVI 2025-26 & 2026-27 "(DOWNLOADED FROM WEBSITE) Last Date of submission 26.05.2025 up to 01.00 PM"**
- 1.3 The Sealed tenders "Cover A" (Technical Bid) submitted by the tenderers will be opened by the CDM&PHO, Sambalpur in the office chamber of the CDM&PHO, Sambalpur at 11.30 AM 28.05.2025 The tenderer or their duly authorized representatives are allowed to be present during the opening of the tenders if they so like.



ELIGIBILITY CRITERIA

2.1 Manufacturing units / Importers/ Suppliers are eligible to participate in the tender provided, they have

- (i) The tenderer must submit GST Certificate along with the upto date GST Return certificate up to March 2025
- (ii) Photo copy of PAN must be submitted by the tenderer
- (iii) An under taking must be submitted by the tenderer that items will be supplied to the consignee along with the test report within 30 days from the issue of the purchase order.
- (iv) Should submit valid Drug License Certificate
- (v) Should submit the Authorization Certificate (If Bidder is not a manufacturer)
- (vi) Should submit the proof of supply to Govt. Hospitals for last three financial years, at least minimum five order copy for each year (2024-25, 2023-24, 2022-23).
- (vii) Should submit the Proof of Average annual turnover of the bidder of Rs.50 Lakh or more in last three (3) financial years should be submitted duly prepared and certified by a chartered accountant.
- (viii) Should submit the EMD of Rs.10000/- (Rupees Ten Thousand only) in shape of DD in favour of ZSS(MISC) Sambalpur from any Nationalized/ Scheduled Bank.



Cover –B (Price Bid) will be opened only of the tenderers who qualify in Technical Bid (Cover – A) and product is as per tender specification.
- 4.1 The tender format (Price Schedule) in the prescribed form (as per Annexure – IV), hard copy must be submitted in Cover-B. The price of the item should be quoted with FOR Destination and exclusive of GST.
- 4.2 The Cover "B" of successful tenderers who qualifies in their technical bid, will be opened at the office chamber of the C.D.M.& P.H.O, Sambalpur by the C.D.M.& P.H.O, Sambalpur on the same day/ decided by the purchase committee members in the presence of the tenderers or their authorized representatives
- 4.3 The rate is valid for Two year from the date of approval of the committee.

1. Price should be omitted from the Primary and secondary packing
2. Odisha Govt. Supply Not for Sale should be printed on Primary and secondary packing.
3. Analytical Test report of each batch should be submitted at the time of the supply.
