Notice inviting Tender for award of contract for providing Group D Manpower in RITI, Larpank, Sambalpur

The Collector-cum-Director, RITI, Larpank, Sambalpur hereby invites Sealed Tenders in the prescribed format from reputed Manpower Service Providers/Agencies having registered office located within the State of Odisha and possessing valid license, statutory clearance, Service Tax Registration, EPF Registration, ESI Registration and PAN No. for providing services of 13(Thirteen) Group-D personnel for RITI, Larpank, Sambalpur for a period of **two years from the date of coming into force of the contract** as would be indicated therein. The contract for supply of 13 nos. of the Group-D personnel (on outsourcing basis) and the mode, manner and nature of duties shall be as per the details provided in the Tender Documents. The agency should have minimum of three years of experience in providing Group-D personnel to Government Department, Public Sector Companies/Banks, etc.

The Tender Documents can be downloaded from the website of the Collectorate, Sambalpur (<https://sambalpur.odisha.gov.in>) or obtained in person from OFFICE OF THE COLLECTOR-CUM-DIRECTOR, RITI, Larpank, Sambalpur on payment of non-refundable cost of tender paper amounting to **Rs.5000/- (Rupees Five thousand)** only in the shape of Demand Draft drawn in favour of **Assistant Director, RITI, Larpank, Sambalpur** payable at **Hirakud** on any working day between 07.00 A.M. to 01.00 P.M. from **09.05.2025 to 23.05.2025**.



As per the FDOMNo.4939 dated 13.02.2012 bidders are required to furnish the Bid Security of Rs.1,00,000/- (Rupees One Lakh) only in the shape of Bank Guarantee/Term Deposit Receipt (TDR) covering the period of contract from any Nationalized Bank drawn in favour of Assistant Director, RITI, Larpank, Sambalpur along with the Tender Documents. The Bid Security will be returned to the unsuccessful bidders after selection of the successful bidder.

SCOPE OF WORK AND INSTRUCTIONS FOR BIDDERS

1. RITI, Larpank, Sambalpur in pursuance to approval of Government in R&DM Department requires the services of reputed, well established and financially sound Manpower Service Providers to provide services of Group-D personnel on contract outsourcing basis for day-to-day office work in RITI, Larpank, Sambalpur.

2. The contract for providing the aforesaid manpower shall continue at the above location for a period of two year from the date of commencement of service. The period of the contract may be further extended for a further period of another one year provided the requirement of the offices for manpower persists at that time. The period of contract may be curtailed /terminated before completion of two year owing to deficiency in service or substandard quality of manpower deployed by the selected Service Provider or because of change in the office requirements. The Collector-cum-Director, RITI, Larpank, Sambalpur, however, reserves the right to terminate the initial contract at any time after giving 15 days notice to the selected Service Provider. **Under no circumstances the manpower/personnel shall be allowed to continue for more than a period of two years, so as to avoid future litigation relating to regularization.**
3. The Group-D manpower shall be engaged as Night-Watchman/ Chowkidar / Chowkidar-cum-Sweeper. The details of placement of 13 (thirteen) Group-D man power in the Office is given above. Any changes there in will be done as per decision of the authority.

4. The contract of service provider shall be terminated if the selected bidder fails to provide the man power having expertise in doing same works in the offices along with additional works that may be assigned to him by the Head of Office concerned /any other authority from time to time as & when required & fails to provide the man power who are in good physical health condition having expertise in the above work and to be vigilant during the silent hours.
5. The estimated cost of the contract is **Rs. 25, 00, 000/- Approx.**(Rupees Twenty five Lakh) only per annum including applicable taxes, statutory dues and negotiated service charges. As desired by authority additional manpower may be engaged on the same terms & conditions based on requirement. Similarly, man power may be curtailed as per decision of authority.
6. The interested Service Providers shall submit the tender document complete in all respects along with other requisite documents by **05:00 PM of 30.05.2025** at the Office of the Collector-cum-Director, RITI, Larpank, Sambalpur by Registered post / speed post for the purpose.
7. The various crucial dates relating to "Tender for Providing Services of Group-D post to the "Office of the Collector-cum-Director, RITI, Larpank, Sambalpur" are cited as above(Page:5 of this tender document).
8. The tender has been invited under two bid systems i.e. Technical Bid annexed at **Annexure-I** and Financial Bid annexed at **Annexure -III**. The interested bidders are required to submit the bids in two separate sealed envelopes super scribing "Technical Bid for Providing Services of Group-D personnel to "Office of the Collector-cum-Director, RITI, Larpank, Sambalpur" and "Financial Bid for Providing Services of Group-D personnel to "Office of the Collector-cum-Director, RITI, Larpank, Sambalpur". Both sealed envelopes should be kept in a third sealed envelope super scribing "**Tender for Providing Services of Group-D personnel to RITI, Larpank, Sambalpur**".
9. All bidders will have to deposit a Non-refundable payment of Rs.5000/- (Five Thousand) only as the cost of Tender Paper in shape of Demand Draft of any Nationalized Bank drawn in favour of Assistant Director, RITI, Larpank, Sambalpur payable at Hirakud along with the Technical Bid.
10. As per the FDOM No.4939 dated 13.02.2012 all bidders will have to deposit a Bid Security of **Rs.1,00,000/- (Rupees One Lakh) only** in the form of Bank Guarantee / Term Deposit Receipt (TDR) from any Nationalized Bank drawn / pledged in favour of Assistant Director, RITI, Larpank, Sambalpur covering the period of contract along with the Technical Bid. The Bid Security Deposit will be returned to the unsuccessful bidders after selection of the successful bidder. The successful bidder will have to deposit a Performance Security Deposit (being 5% of the cost of the contract) in the shape of Bank Guarantee/ Term Deposit Receipt (TOR) from any Nationalized Bank drawn in favour of Assistant Director, RITI, Larpank, Sambalpur covering the period of contract. The successful bidder may deposit the balance amount after deducting the bid security deposited.

11. The interested Manpower Service Providers are required to enclose the Self attested documents as mentioned in Annexure-V along with the Technical Bid, failing which their bids shall be summarily/out rightly rejected and will not be considered.

The conditional bids shall not be considered and will be out rightly rejected.

13. All entries in the tender form should be legible and filled clearly. If the space for furnishing information is insufficient, a separate sheet duly signed by the authorized signatory may be attached. No overwriting or cutting is permitted in the Financial Bid Form. In such cases, the tender shall be summarily rejected. However, the cutting, if any, in the Technical Bid Application must be initialized by the person authorized to sign the tender bids.
14. The Technical Bids shall be opened on the scheduled date and time i.e. at 10.00AM on 31.05.2025 in the Chamber of ADM, Sambalpur in presence of the Selection Committee and the representatives of the Manpower Service Providers, if any, who wish to be present on the spot at the time of opening of the Bids.
15. The Financial bids shall be opened on the scheduled date and time at 10.30 AM on 03.06.2025 in the Chamber of ADM, Sambalpur in presence of the Selection Committee and the representatives of the Manpower Service Providers, if any, who wish to be present on the spot at the time of opening of the Bids.
16. The Selection Committee can use its own discretion for selection of the service provider; the decision taken by the Committee shall be final.
17. The Collector-cum-Director, RITI, Larpank, Sambalpur reserves the right to reject any or all bids without assigning any reason.

TECHNICAL REQUIREMENTS FOR THE TENDERING MAN POWER SERVICE PROVIDER

The tendering manpower service provider agencies should fulfill the following technical specifications:

- (a) The registered office of the manpower service provider agency should be located within the State of Odisha and Branch Office should be within the jurisdiction of undivided Sambalpur district. Document in support of Branch Office be furnished viz- Electricity bill, Bank A/c of the firm in the district. Registration Certificate has also been required under Shop and Establishment Act of MPL/ULB or Trade license etc.
- (b) The agency should have been registered with the appropriate registering authority.
- (c) The agency should have at least "three years" experience in providing manpower **to any Govt. organization.**
- (d) The agency should have own Bank Account.
- (e) The agency should be registered with Income Tax and Service Tax (GST) department.
- (f) The agency should be registered with appropriate authorities under Employees Provident Fund and Employees State Insurance Acts.
- (g) The agency should have any other regulatory clearance (to be specified by the user Department) that may be required for providing man power services.
- (h) The agency should have minimum average annual turn-over of Rs.01 (One) Crore during the financial year 2022-23, 2023-24 & 2024-25 in providing man power services.
- (i) The agency should not have any criminal antecedent/ previous unsatisfactory service report/ previously black listed by any organization.

**TECHNICAL REQUIREMENTS FOR MANPOWER TO BE DEPLOYED BY THE
SUCCESSFUL MANPOWER SERVICE PROVIDER IN RITI, Larpank, Sambalpur**

1. The Group-D personnel should be above 18 years and not more than 50 years of age.
2. Their minimum educational qualification must be 7th pass.
3. Preference should be given to the candidates of Sambalpur district.
4. They may have experience in doing similar works. The applicant must be in good physical health condition and to be vigilant during the silent hours. Lack of knowledge of the above-mentioned works will lead to their immediate disengagement.
5. They must not have any criminal antecedent. Each Group D personnel, at the time of his engagement, shall furnish as self-declaration of not having any criminal antecedent duly verified and certified by the Agency to the Authority.

1. The total rates quoted by the Service Provider should be inclusive of all statutory/ tax liabilities in force at the time of entering into contract.
2. The payment shall be made on conclusion of the calendar month only on the basis of number of working days for which duty has been performed by each man power.
3. The minimum service charge shall be 3.85% (3%profit. Plus transaction charges provided that the service charges should not exceed 7% in any case).

TERMS AND CONDITIONS

GENERAL

1. The Agreement shall be valid for two year unless it is curtailed or terminated by the authority owing to deficiency of service, sub-standard quality of manpower deployed, breach of contract etc. or change in requirements.
2. The Agreement shall automatically expire after completion of two year unless extended further by the mutual consent of the Manpower Service Provider and Authority.
3. The Agreement may be extended, on the same terms and conditions or with some additions/ deletions/ modifications, for a further specific period mutually agreed upon by the Man Power Service Provider and Authority. However, **under no circumstances the manpower/personnel engaged shall be allowed to continue for more than two years, so as to avoid future litigation relating to regularization.**
4. The Man Power Service Provider shall not be allowed to transfer, assign, pledge or sub contract its rights and liabilities under this agreement to any other agency or organizations by whatever name be called without the prior written consent of the Authority.
5. Collector-cum-Director, RITI, Larpank, Sambalpur at present, has made the requirement of 13 (Thirteen) nos. of Group-D personnel on urgent basis for day-to- day official work at RITI, Larpank, Sambalpur as indicated above.
6. The Man power Service Provider will be bound by the details furnished by into the Authority while submitting the tender or at subsequent stage. In case, any of such documents furnished is found to be false at any stage, it would be deemed to be a breach of terms of Agreement making it liable for legal action besides termination of the agreement and forfeiture of performance Security. Action as deemed proper shall be initiated against the Service Provider Agency.
7. The Authority reserves the right to terminate the agreement at any time during the period of contract after giving 15 days' notice to the Man Power Service Provider.
8. The persons deployed in the Offices besides normal working hours will be called on holidays to attend duty if required in case of urgency. They are entitled for special leave as per FDOM No. 30794 dated 06.11.2021.
9. The Manpower Service Provider shall nominate a coordinator who shall be responsible for immediate interaction with the office of the Collector-cum-Director, RITI, Larpank, Sambalpur and concerned Head of Offices so that optimal services of the persons deployed could be availed without any disruption.
10. The entire financial liability in respect of man power services deployed in the Offices mentioned above shall be that of the Man power Service Provider and neither the Collector-cum-Director, RITI, Larpank, Sambalpur nor Head of Offices concerned will no way be liable. It will be the responsibility of the Manpower Service Provider to pay to the person deployed a sum not less than the minimum rate quoted in the financial bid and produce such evidence as may be required by the Collector-cum-Director, RITI, Larpank, Sambalpur.

11. For all intents and purposes, the Manpower Service Provider shall be the "Employer" within the meaning of different Rules & Acts in respect of man power deployed. The persons deployed by the Manpower Service Provider shall not have any claim whatsoever like employer and employee relationship against Collector-cum-Director, RITI, Larpank, Sambalpur or Head of Office concerned.
12. The Manpower Service Provider shall be solely responsible for redress of grievances or resolution of disputes relating to persons deployed. Collector-cum-Director, RITI, Larpank, Sambalpur or Head of Office Concerned shall, in no way, be responsible for settlement of such issues whatsoever.
13. The Collector-cum-Director, RITI, Larpank, Sambalpur or Head of Office Concerned shall not be responsible for any financial loss or any injury to any person deployed by the Manpower Service Provider in the course of their performing the functions/duties, or for payment towards any compensation.
14. The persons deployed by the Manpower Service Provider shall not claim nor shall be entitled to pay, perks and other facilities admissible to regular/confirmed employees during or after expiry of the Agreement.
15. In case of termination of this agreement on its expiry or otherwise, the persons deployed by the Manpower Service Provider shall not be entitled to and shall have no claim for any absorption in regular or other capacity.
16. The person deployed shall not claim any benefit or compensation or absorption or regularization of deployment with office. Undertaking from the person deployed to this effect shall be required to be submitted by the Manpower Service Provider at the time of commencement of such deployment.
17. The Manpower Service Provider must be registered with the concerned Govt. Authorities i.e. Labour Commissioner, Provident Fund Authorities, Employees State Insurance Corporation etc. and a copy of the registration should be submitted. The Manpower Service Provider shall comply with all the legal requirements for obtaining License under Contract Labour (Regulations and Abolition) Act, 1970 if any, at his own part and cost.
18. The Manpower Service Provider shall provide a substitute well in advance if there occurs any probability of the person leaving the job due to his own personal reasons. The payment in respect of the overlapping period of the substitute shall be the responsibility of the Manpower Service Provider. The Manpower Service Provider shall be responsible for contributions towards Provident Fund and Employees State Insurance, wherever applicable.
19. The persons deployed by the Manpower Service Provider should have good police records and no criminal case should be pending against them. Police verification of the antecedents of the deployed personnel can be made at the discretion of the Collector-cum-Director, RITI, Larpank, Sambalpur.
20. The persons deployed should be polite, cordial and efficient while handling the assigned work and their actions should promote good will and enhance the image of the office.
21. The agency must not have been blacklisted by any Central / State Government any other public sector undertaking or any authority during the recent past. An undertaking to this effect shall be furnished by the Bidders as per the prescribed format at FORMT2.

LEGAL

1. The persons deployed shall not commit any mischief in any form with the case records, documents, registers and files. In view of this, they shall be required to maintain confidentiality and breach of this condition shall make the Manpower Service Provider as well as the person deployed liable for penal action under the applicable laws besides, action for breach of contract.
2. The Manpower Service Provider shall be responsible for compliance of all statutory provisions to minimum wages payable to different types of workers in respect of the persons deployed. The Collector-cum-Director, RITI, Larpank, Sambalpur shall have no liability in this regard.
3. The Manpower Service Provider shall also be liable for depositing all taxes, levies, Cess, etc., on account of service rendered by it to the concerned tax collection authorities, from time to time, as per the Rules and Regulations in the matter. Attested Xerox copies of such documents shall be furnished to the Collector-cum-Director, RITI, Larpank, Sambalpur as and when required.
4. The Man power Service Provider shall maintain all statutory registers under the law and shall produce the same, on demand, to the Collector-cum-Director, RITI, Larpank, Sambalpur or any other authority under law.
5. The Tax Deduction at Source (TDS) shall be done as per the provisions of Income Tax Act / Rules, GST Act/ Rules, as amended, from time to time and a certificate to this effect shall be provided by the Man power Service Provider.
6. In case the Manpower Service Provider fails to comply with any liability under appropriate law and as a result thereof, the Collector, Sambalpur is put to any loss/obligation, monetary or otherwise, the Collector, Sambalpur will be entitled to get itself reimbursed out of the outstanding bills or the Performance Security Deposit of the Manpower Service Provider, to the extent of the loss or obligation in monetary terms.
7. The Agreement is liable to be terminated because of non-performance, deviation of terms and conditions of contract, non-payment of remuneration of employed persons and non-payment of statutory dues. The Collector, Sambalpur will have no liability towards non-payment of remuneration to the persons employed by the Man power Service Provider and the outstanding statutory dues of the service provider to statutory authorities. If any loss or damage is caused to the Offices by the person deployed, the same shall be recovered from the unpaid bills or adjusted from the Performance Security Deposit.

FINANCIAL

1.
