
The Divisional Forest Officer, Bamra Wildlife Division, Bamra, Sambalpur on behalf of Governor of Odisha invites Percentage Rate bids in single cover in online mode for construction of building works as detailed in the table below from the class of eligible contractors as mentioned in column-5 (five) registered with the State Governments and Contractors of equivalent Grades /Class Registered with Central Government / MES / Railways or other licence authorities for execution of Building works (Composite works). The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under state government has to register under the state PWD in appropriate class of eligibility before signing of the agreement. The bidder may submit the following works.

2. The bidder shall transfer the cost of bid documents through online as shown in column-6 above through a process as mentioned in DTCN.
3. The Bid documents will be available in the website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) / [www.odishaforest.in](http://www.odishaforest.in) // <https://sambalpur.odisha.gov.in> from 18.00 hours of 20.10.2025 to 17:00 Hours of 28.10.2025.
5. The Bidder must possess **Compatible Digital Signature Certificate (DSC)** of Class C or D.
6. Bids shall be received only "On-line" on or before 17:00 Hours of Dtd.28.10.2025.
7. Bids received "on-line" shall be opened at 11:00 Hours on dtd. 29.10.2025 in the office of the **Divisional Forest Officer, Bamra Wildlife Division, Bamra, Sambalpur, Odisha** in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids

after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.

8. Bidders are to submit only the original BOQ of uploaded by publisher after entering the relevant fields without any alternation/ deletion/ modification multiple BOQ submission shall lead to cancellation of bid.
9. As it is a percentage rate tender, the bidder putting zero value is valid and will be taken as scheduled of rate.
10. Authority will not be held responsible for any technical problem/ failure of network, server during the schedule dates of online bidding.
11. Other details can be seen in the bid documents.
12. The intending bidders are required to furnished their email address and cell phone numbers to inform them any message relating to the tenders.
13. The SC/ST Contractors willing to avail the facilities as fixed by Govt. will submit Scan copy of the affidavit for the same along with tender documents, otherwise they will not be entitled to avail such facilities.
14. The Addl Performance Security shall be deposited by the successful bidder if the bid amount is less than the estimated cost as per amendment to Para No.3.5.5 (V) of OPWD Code Vol- I modified by the Works department vide Office Memorandum No. 4559 Dt.05.04.2021 as given in DTCN.
15. The items covered in **Clause No-126 of DTCN** for building works are required as essential criteria for eligibility for qualification, Checklist should be duly filled in.
16. Detailed information as contained in the D.T.C.N. shall have to be strictly adhered to while submitting the tender papers.
17. This notice is to be read with all the Clauses / addendum to the "Procedure to participate in online bidding". Any corrigendum / Addendum will be displayed in the website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) only.
18. If any of the intending bidders wish to withdraw from participation in the bid, he/she can freely withdraw from the participation before scheduled date and time of closure, failing which action as deemed fit as per relevant codal practice will be taken against him/her.
19. Any tenderer desires to avail any facility as per certain circular /order of Govt. have to apply for same along with tender paper. Claim at the time of opening of tender or later will not be entertained.
20. The online bidder shall have to produce the original documents for verification in support of scanned copies and statements uploaded in the portal within three days from the date of opening of the bid.
21. As per OPWD code **clause 12.4 (Appendix-IX(A))** the contractors participated in the above tender mandated to **register themselves in Contractor Data Base Management System (CDMS) available at [www.cdmsodisha.gov.in](http://www.cdmsodisha.gov.in).**
22. This is a time bound works to be completed within the stipulated period. The respective bidders are advised to study the scope of works and survey the site for concentrate if any and assess their bid capacity and capability before submitting their tenders.
23. The Tenders in complete shape should be uploaded with a valid registration certificate, PAN Card, GST certificate, TP Cost and affidavit in schedule F in the prescribed format.
24. Conditional tender will be summarily rejected. **The Authority reserves the right to reject any or all bids without assigning any reason thereof.**
