1. Tender are invited in Two bid system i.e. Technical Bid & Financial Bid. The Technical Bids must be submitted along with all required documents and Bank Drafts towards the Cost of Tender Paper and E.M.D. and the Financial Bids must be consisting of flat discount offer on the publisher price for the complete order, journal-wise discount will not be accepted. The Technical Bid & Price Bid must be sealed separately in individual cover and both the covers of bids are to be packed and sealed and submitted in a single cover. Both the covers of the bids must be marked as Technical Bid and Financial Bid and the containing Cover of both the bids should be superscribed as **TENDER FOR SUBSCRIPTION OF JOURNALS FOR THE YEAR 2026** on the top and submitted to the Dean & Principal, VIMSAR, Burla-768017, Odisha by Speed Post/Regd.Post/Courier only latest by **01.12.2025** at **5.00 PM**. All the attached documents should be having page number and signature of the bidder with seal.
2. The bidder/Company must be a registered firm in India and continuing the business for the last 20 Years or more and must be a member of FBPAI continuously for last 15 years or more.
3. Bidder/Company must be having Authorization Certificate from the Publishers like Thieme, Sage, John Wiley, Taylor & Francis, BMJ, Cambridge University Press, JAMA, Annual Reviews, Wolters Kluwer etc. for the year 2026. In case of submitting fake certificate, the EMD will be forfeited. Authentication of authorization certificate may be verified by the Authority of Veer Surendra Sai Institute of Medical Sciences & Research Burla if required.
4. The DD of Rs.2000/- (Non-Refundable) towards the cost of Tender Paper and Rs.2,00,000/-towards E.M.D. drawn in favour of Dean & Principal, VIMSAR , Burla must be attached with the Technical Bid. The EMD of the non- qualifying firms will be refunded after finalization of the Tender process.

2. **Payment** – The supplier shall remit the cost of journals to the Publisher using their own funds and submit the Invoice along with the Remittance proof and Publisher price proof to claim the amount from **Veer Surendra Sai Institute of Medical Sciences and Research, Burla**. The bank conversion rate will be charged in the bills for foreign journals. (Proof to be attached) with bill/invoices.
3. **Bank Guarantee** – The supplier has to deposit 100% of the total value of invoice in the form of Bank Guarantee valid for a period of 02(two) year.
4. **Delivery commencement:** The supplier should inform the time required for commencement of delivery of journals from the date of order.


