**Existing Provision:-**

The work should be completed within 45 days from the date of issue of work order. In case of delay of work from 45 days to 75 days, a penalty of 2% will be imposed on the total contract amount. If the duration exceeds more than 75 days, the work order shall be deemed cancelled without any refund.

**Revised Provision (Read as Under):-**

The work shall be completed within 120 days from the date of issue of work order. In case of delay of work from 120 days to 150 days, a penalty of 2% shall be imposed on the total contract amount payable to the vendor. If the duration exceeds more than 150 days, the work order shall be deemed cancelled without any refund.

All other terms and conditions of the Short Tender Call Notice shall remain unchanged and binding.
