







"QUOTATION CALL NOTICE FOR THE YEAR 2025-26

Submission Details:-

1. Quotations shall be submitted through postal / by hand only along with sample in two packets (i) Technical bid & ii) financial bid separately both enclosed in one envelope.

- (i) The envelope should be labelled with the following:
"Quotation for [Item Name]- "Your company name"
Ex:- "Quotation for Khaki- Coloured Cloth-[your Company Name]
- (ii) Copies of Valid Pan Card and GST certificate should be enclosed with the quotations
- (iii) The Quotation must be submitted separately for each item as vendors may choose to bid for one or more items. The selection of suppliers will be based on the price, quality and suitability of each product.
- (iv) All quotation shall reach the office of the undersigned on or before 2 PM of 06.02.2026.
- (v) The quotations will be opened on dt 06.02.2026 at 3.30 PM by the purchase committee.
- (vi) Late submission of quotations will not be taken into consideration.

2. **Criteria for Selection:**

- (i) Price, quality and durability will be considered in the selection process by the selection committee.
- (ii) The purchase committee reserves the right to accept or reject any quotation without assigning any reason thereof.

3. **Delivery :-** Delivery should be within 7 days of the issue of the supply order. No extra delivery charges will be paid.

4. **Term and Conditions:-**

- (i) All quotations must be submitted separately for each item listed.
- (ii) If submitting quotations for multiple items, each item must have a separate envelope.
- (iii) Vendors should include relevant samples along with their quotations.
- (iv) The purchase will be made subject to the availability of funds.
- (v) Payment will be made as per the agreed terms upon delivery.
- (vi) Non-compliance with the specifications or failure to meet delivery deadlines may result in cancellation of the order and blacklisting from future tenders.
- (vii) Undertaking for Delivery:- Within 7 days from issue of supply order to the successful bidder. Non delivery within the stipulated time shall attract penal charges as per decision of Divisional Purchase Committee & may lead to rejection of the bid in total without assigning any reason thereof.
- (viii) The Seller shall not assign the Contract to any person in whole or part without obtaining the prior written consent of the buyer. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer. The seller shall himself bind himself & be responsible to the buyers.
- (ix) The L1 bidder shall deliver the equipment and the accessories to the Divisional Forest Officer, Bamra Wildlife Division, Bamra, Dist:-Sambalpur, Odisha physically by hand only in a company sealed pack. In case of tampering of the pack in any form, the material shall not be accepted. No other modes shall be accepted for receiving the items.

- (x) The Authority reserves the right to withdraw or relax any of the terms and conditions mentioned above so as to overcome any problem encountered at a larger stage at the sole discretion of the authority
- (xi) The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25% of the bid quantity at the time placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during continuity of the contracted rates. Bidders are bound to accept the orders accordingly.
