- 4) The Bidder must possess **Compatible Digital Signature Certificate (DSC) of Class II or Class III.**
- 5) **Bids shall be received only “On-line” on or before 17:30 Hours of Dtd.14.01.2026.**
- 6) Bids received “on-line” shall be opened **at 10:30 Hours on dt. 15.01.2026** in the office of the Divisional Forest Officer, Rairakhhol K.L. Division, Odisha in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging in to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
- 7) The items covered in **Clause No-122 of DTCN** for roads and building works are required as essential criteria for eligibility for qualification, Checklist should be duly filled in.
- 8) The bidder shall transfer online the cost of bid documents as shown in **column-7** above through a process as mentioned in DTCN.

- 9) Detailed information as contained in the D.T.C.N. shall have to be strictly adhered to while submitting the tender papers.
- 10) This notice is to be read with all the Clauses / addendum to the "Procedure to participate in online bidding". Any corrigendum / Addendum will be displayed in the website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) only.




