
Respected Sir,

In inviting a kind reference to the subject cited above and letter under reference, I am to inform that, M/s. Gopal Enterprises has filed writ petition before the Hon'ble High Court of Orissa vide WP(C) No.5420 of 2026 challenging the recovery proceedings initiated against the owner of the goods loaded in vehicle bearing No OD15W 1994.

As per order of the Hon'ble High Court of Orissa, the petitioner has deposited the due amount of penalty Under Section 129(1)(a) of the GST Act on dt.28.02.2026 and also submitted an under taking that, in the event the writ petition fails he shall be bound to discharge the liability as per order dated 30.01.2026. In obedience to the order of the Hon'ble High Court of Orissa, the detained vehicle bearing No-OD-15-W-1994 and goods are released on dt.28.02.2026.
