The **Block Development Officer, Kuchinda** on behalf of Governor of Odisha invites **Percentage Rate** bids in single cover system for the construction of works as detailed in the table, from the class of eligible contractors as mentioned in column-5 (five) registered with the State Governments and Contractors of equivalent Grades / Class Registered with Central Government / MES / Railways, to be eventually drawn up in **PWD P-1 Agreement** form, for execution of Buildings i.e. **civil works**. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under state government has to register under the state PWD in appropriate class of eligibility before signing the agreement. The bidders may submit bids for the following work.

1. Bid documents consisting of plans, specifications, the schedule of quantities and the set of terms & conditions of contract and other necessary documents can be seen in the office of the undersigned during office hours every day except on Sunday & Public holidays till last date of sale and receipt of tender paper. The Bid documents will also be available in the website <https://tendersodisha.gov.in> from **19.03.2026 to 07.04.2026**.
2. Bids must be accompanied with E.M.D. (Bid Security) of the amount specified for the work in the table **Col.4** above in shape of N.S.C./P.O.T.D / Post Office Savings Pass Book / Deposit receipt of any Scheduled Bank (Valid minimum one year from the date of receipt) duly pledged in favour of **Block Development Officer, Kuchinda**. Bidders desirous of hiring machinery or equipment from outside of the State are required to furnish 2% of the amount put to tender as bid security instead of 1%. Bids without E.M.D. or in other shape will not be considered and liable for rejection.
N.B: - E.M.D. in shape of Cash / Pay Orders or Bankers Cheques / Bank Draft is not acceptable.
3. The bid document will be available on the website <https://tendersodisha.gov.in> from **10:00 A:M** of **19.03.2026 to 5:00 P:M** of **07.04.2026** for online bidding.
4. Bidders must possess compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
5. The Bid will be opened on **Dt 09.04.2026 at 11:00 A.M.** in the office of the undersigned in the presence of the members of the District Level Tender/ Purchase Committee and the bidders or their authorized

representative. Bidders who participate in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of receipt / opening of the bids as specified, above will be received / opened on the next working day at the same time and venue. The tender committee reserves the right to make amendments or changes during opening of tenders.

6. Tender paper costs must be paid through e-payment gateway as mentioned in the DTCN.
7. Additional Performance Security (APS) shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidders who have quoted less bid price/ rates than the estimated cost put to tender shall have to furnish the exact amount as per Works Department Office Memorandum No.173/W., Bhubaneswar Dated.03.01.2026. Additional Performance Security (APS) must be furnished in shape of Demand Draft/ Term Deposit Receipt duly been pledged in favor of Block Development Officer, Kuchinda, within seven days of issuance letter of acceptance (LOA), otherwise the bid shall be cancelled, and the security deposit shall be fortified. Further proceeding for blacklisting shall be initiated against the bidder.
8. In case of Engineering Contractors seeking exemption of EMD are instructed to enclose an affidavit regarding the list of works awarded during the current financial year 2025-26 with exemption of EMD along with an application to avail the same for this work and will submit copy of original contract license and produce the original license at the time of opening of tender, otherwise the bids will be rejected.
9. Scheduled Caste and Scheduled Tribe Tenderers will be given concessions where their tenders are within 10% of the rate quoted by the lowest tenderer, for any work, the work may be considered for award to him/ them at the lowest tendered rate. The Security deposit at half the usual rate may be deposited/realized by/from the Scheduled Caste or Scheduled Tribe contractors coming under categories up to "B" class only as against the permissible percentage under Rule 13 of the PWD contractor's regulations rules.
10. **Abolition of Threshold Negative Bid Cap:** The extant provision of threshold negative bid cap of 14.99% as introduced under Appendix-IX Clause-36 of the OPWD code, Volume-II, stand abolished. Accordingly, in respect of procurement of works undertaken by the Government of Odisha and its agencies, no threshold negative bid cap of 14.99% shall be applicable for this tender. This tender shall be governed by the provisions as amended by Government Letter No.173/W Dt.03.01.2026 Works Department.
11. The percentage quoted in the tender without mentioning excess or less shall be treated as excess.
12. Validity of tender shall be 90 days from the date of opening of tender.
13. Other details can be seen from the bidding documents.
14. The authority reverses the right to cancel any or all the bids without assigning any reason.
15. The addendum/corrigendum if any will be hosted on the website/office notice board only.




