Corrigendum Notice

The RFP document issued on dated-25.03.2026 vide notice no. 244/TDO,SBP for onboarding of an agency for upkeeping the Safety, security & Sanitation at Huma & Ghanteswari, suffers from typographical error at some portion of the document. Hence the said portion of the RFP document is hereby corrected in the following areas, such as;

1. Tender document cost/Bid Processing fees (non-refundable) is **Rs.2000/- (Rupees two thousand only)** in the page no.03,
2. Point no. 21.1 under "**Performance security**" in the page no.16, which may be read as

"The Successful Bidder shall be required to furnish a Performance Security prior to sign the contract (for an amount which is **5% of the annual contract value**) in the form of Insurance Surety Bonds, Account Payee Demand Draft, Fixed Deposit Receipt from a Commercial Bank, Bank Guarantee (including E- Bank Guarantee) from a Commercial Bank in an acceptable form in favor of District Collectorate, Sambalpur , payable at Sambalpur. The Performance Security shall be valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations. In case the contract period is extended, further, the validity of Performance Security shall also be extended by the Successful Bidder accordingly. The format for BG for Bid Security is provided at **Annexure-XII**".

3. Section -B under "**Annexure-VIII**" in the page no. 54, the information asked may be **submitted by the Successful bidder after the award of the contract.**
4. Estimated Resource Cost under **Annexure-X** in the page no. 56, which may be read as

"Note: The total estimated resource cost in the Annexure-X includes Employer's contribution of EPF and ESI only, **while Bonus, Gratuity and Leave allowances are excluded.**"

5. Point no. 1 of draft contract under **Annexure XI** in the page no. 59, which may be read as

**"NOW, THEREFORE, IT IS HEREBY AGREED** between the parties as follows:
