01. Tender OF INTERSTED REPUTED Travel Agencies / Tour Operator or private individuals for providing AC Petrol/Diesel driven vehicle having sitting capacity not more than ten including driver, which shall conform the Terms and condition in Annexure-III will be engaged for Field Works in Sambalpur Forest Division on monthly rent basis in pursuance.
02. The Vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Pollution Certificate, valid contract carriage Permit, proof of up-to-date tax payment etc. which are mandatory for plying of vehicle.
03. The Driver of the Vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
04. The Driver should be decently dressed, well behaved, gentle and obedient in nature.
05. A sum of Rs. 5000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the Divisional Forest Officer, Sambalpur Forest Division and submitted along with tender as security deposit. After completion of the tender process, the amount will be refunded to unsuccessful bidders.
06. The monthly rate of hire charges be quoted separately in the general bid information in Annexure-I (Excluding fuel and lubricants)
07. The details of the make and year of manufacture of the vehicle, Registration No., Mileage (KMs covered per liter) and name of the Driver with Driving License No and period of validity should be specifically provided in the general bid information to be furnished with the Quotation / Tender (Annexure-I)
08. The Quotation completed in all respect should reach the undersigned on or before 07.05.2026 by 1.00 PM and shall be opened on 08.05.2026 at 11.00 AM in presence of the bidders or their authorized representative.

**ANNEXURE – III**

**TERMS AND CONDITIONS FOR HIRING OF VEHICLE (MAHINDRA BOLERO/BOLERO NEO)**

The following terms and conditions must be fulfilled by successful bidder for proving a vehicle on hire on monthly rent basis:

01. The hired vehicles, during period of contract, shall have all necessary valid MV documents such as: - Valid Registration Certificate, Insurance Certificate, valid Contract Carriage Permit, Proof of up-to-date tax payment etc. and D.L. of the driver available all the times. The Department/ Office hiring the vehicle shall not be responsible for any damage / loss caused to hired vehicle or loss of life / injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.
02. The hire charges to be paid for monthly basis is final but does not include cost of diesel, which is to be paid separately basing on actual consumption and lubricants as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, lubricating oil of Engine, Gear Box & different Coolant, Tires & Tubes, Battery etc. will be borne by the bidder.
03. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
04. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/ bidder.
05. In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.
06. The vehicles shall report for duty for minimum of 25 days in a month.
07. In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
08. Monthly hire charges and reimbursements towards cost of Petrol/diesel (as per actual) and lubricants (as per Govt. norms) of selected bidder will be paid in every succeeding month, as per as possible within fifteen days of the submission of bills by the service provider and no advance payment will be made.
09. The vehicle shall not be more than 3 years old from the initial registration and also in good running condition during the period of contract.
10. If the Services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
11. In case the service provider intends to withdrawn the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
12. If the bidder violates any of the terms and contract, Government shall forfeit the entire amount of security deposit.
