12. Bidding is open to all eligible bidders as defined under Odisha Contractors Registration Act of Works Department from time to time. Bidders registered as **mentioned against works** as per eligibility criteria of class to each work in Annexure to Bid Notice column-7 under the Government of Odisha/ Other State Government/ Government of India/ State or Central Government Undertakings is also eligible to bid. The registered bidders outside the state can also participate in this online tender process after necessary portal enrollment, but shall have to subsequently undergo registration with appropriate authority within one month from acceptance of tender. Bidders are advised to note the minimum qualification criteria specified in instruction to bidders to qualify for the award of the contract. Interested bidders may obtain clarifications regarding the minimum qualification criteria from the office of the Additional Chief Engineer, N.M.I Circle, Sambalpur prior to participation in the bid.
13. Bidding documents can only be available on-line in the Government of Odisha website (<http://tendersodisha.gov.in>) from **02.06.2026 to 11.06.2026 up to 05.00 PM** for preview, download & submission.
14. The Bidders desiring to participate in “**On-line**” bidding must possess compatible **Digital Signature**

Certificate of Class-II or Class-III. The web site for the on-line bidding is <http://tendersodisha.gov.in>.

15. Bids must be accompanied by a non-refundable fee as indicated at Column-6 of Annexure towards cost of Tender Paper and the amount specified at Column-5 as Earnest Money Deposit/ bid security for the works. The cost of Tender Paper and Earnest Money Deposit / bid security are to be remitted online as per instruction issued in Works Department office Memorandum No.17254 dated 5.12.2017. Scanned clear copies should be uploaded. The Bidders desire to hire machineries or equipments from outside the state or owned but deployed outside the state are required to furnish 2% of the amount put to tender as Bid Security. Only those bidders who successfully remit their cost of Tender Paper and Earnest Money Deposit on submission of bids would be eligible to participate the tender / bid process. The bidders with pending of failure payment status shall not be able to submit their bid. Tender inviting authority, State Procurement Cell, NIC the designated Banks shall not be held responsible for such pendency or failure.
16. Tender shall be uploaded separately for Technical Bids (Cover-I) & Financial bid (Cover-II) etc in standard formats prescribed in the bid documents displayed at Govt. of Odisha e-market place web site & submitted duly filled up. The on-line bidders should upload the **scanned clear copy** of the **affidavit** in support of correctness or proof of the information submitted including Bid Security accompanied with tender by them. They should **digitally sign** on all statements, documents, certificates uploaded by them, owning responsibility for their correctness/ authenticity. If the documents are not digitally signed, an **affidavit** owing genuinely of the documents should be uploaded. The affidavit of authenticity of documents uploaded by the bidder being a legal document, checking genuinely of signature put on other uploaded documents including affidavit and lease deeds is beyond purview of the officer inviting tender. The bidder himself is liable for the authenticity of the documents if challenged by any other bidder or in the court of law.
17. **The cover-1 (Technical Bid) will be opened in the office chamber of the Additional Chief Engineer, N.M.I Circle, Sambalpur at 11.00 hours on dt: 12.06.2026 in presence of the bidders who wish to attend. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue. Opening of Cover-II (Financial Bid) shall be intimated through web site specified for the purpose in e-tendering process to those bidders who will be found eligible after evaluation of Technical Bid (Cover-I).**
18. One bidder can submit only one tender paper to each of the works for which tender invited in this notice in his own DSC. Submission of more than one tender paper for any particular of work by a bidder through different DSC or through his own DSC for a particular tender will be liable for rejection of all such tenders.
19. Fixed deposit holders/ Exemption holders by order of Central/ State Govt. will also be required to furnish the requisite security amount along with the bid in the prescribed form, otherwise the bid shall be considered as non-responsive. Engineering Contractor desires to avail the facility of exemption of E.M.D is required to submit an affidavit to the effect that he has not yet availed the facility for more than 2 (two) works during the current financial year. **The name of work for which and the authority to which the tender is being submitted must be mentioned in the affidavit, failing which he will be not entitle to get any facility. Similarly, ST/ SC contractors seeking exemption of 50% EMD or price preference required to produce an affidavit to this effect. The ST/SC contractors having Degree/ Diploma in Engineering are not allowed to avail both the benefits. Both Engineering and ST/SC contractors should submit the affidavit in writing regarding the facility to concerned officer inviting tender, otherwise they will not entitle to get the facility.**
20. **The successful Bidder who has quoted less bid/ rate than the value of work put to bid shall have to furnish Additional Performance Security as per the OM No.07764600022025 173/W, Bhubaneswar dtd.03.01.2026 of Works in shape of N.S.C/Postal Saving Bank Pass Book / K.V.P / Post Office Term deposit receipt / Deposit receipt of any Nationalized /Schedule Bank duly pledged in favour of the Superintending Engineer, M.I. Division, Jharsuguda within seven days of issue of Letter of Acceptance (LoA) by the Divisional Officer (by e-Mail or WhatsApp) to the successful bidder**

otherwise the bid of the successful bidder shall be cancelled and the Earnest Money Deposit/ Bid Security shall be forfeited. Further proceeding for blacklisting shall be initiated against bidder.

Additional performance security shall be taken on an incremental basis from the selected bidder for low bid prices in the project works as per OM No.07764600022025 173/W, Bhubaneswar dtd.03.01.2026 of Works Deptt. as follows: -

- I. Where the bid price is below 0% but not below 10% of the project cost put to bid, no additional performance guarantee/security percentage is required.
 - II. Where the bid price is below 10% but not below 20% of the project cost put to bid, the additional performance guarantee/security percentage shall be incremented by 0.1% for every percentage of bid price below 10% of the project cost put to bid starting at 11% with the additional bid performance guarantee being 0.1% and this additional performance guarantee percentage shall be applied on the bid price.
 - III. Where the bid price is 20% or more below of the project cost put to bid, the additional performance guarantee percentage shall be incremented by 0.2% for every percentage of bid price below 20% of the project cost put to bid in addition to addition to 1% of the bid price and this additional performance guarantee percentage shall be applied on the bid price.
 - IV. The additional performance guarantee percentage shall be rounded off to the next lower percentage based on whether the decimal point of the percentage of bid price is below 0.5% or next higher percentage based on whether the decimal point of the percentage of bid price is 0.5% or more.
 - V. The additional performance security shall be treated as part of the performance security.
 - VI. Justification for abnormally low bids shall be scrutinized by the Departmental Technical Committee and recommended to the competent authority of the Administrative Department for the approval of the Additional Performance Security (APS). An abnormally low bid is one in which the Bid price, in combination with other elements of the Bid, appears so low that it raises material concerns as to the capability of the Bidder to perform the contract at the offered price. Procuring Entity may, in such cases, seek written clarifications from the Bidder, including detailed price analyses of its Bid price in relation to scope, schedule, resource mobilization, allocation of risks and responsibilities, and any other requirements of the bid document. If, after evaluating the price analyses, the procuring entity determines that the Bidder has substantially failed to demonstrate its capability to deliver the contract at the offered price, the Procuring Entity may reject the Bid/proposal. However, it would not be advisable to fix a normative percentage below the estimated cost, which would automatically be considered as an abnormally low bid.
21. The amount quoted by bidders shall remain valid for 90 (ninety) days from the date of opening of financial bid. If any bidder backs out from the bidding process, or make any request for alteration or modification in terms & conditions of the bid shall debar the bidder from participating in the online bidding system and his portal registration shall be blocked including recommendation to registering authority for cancellation of his registration as contractor including forfeiture of bid security deposited.
 22. **The preferences /Relaxations granted to local Micro & Small enterprises (MSEs) and Startups in the procurement of works, as per works OM No. 503/W dated 17.01.2022 have been withdrawn. Effective from the date of Work OM no. 4281/W dated 05.03.2025, these relaxations will no longer be acceptable.**
 23. Quality control tests as per specification for all items of the work executed will be taken in nearby Government Quality Control Laboratories of Minor / Medium / Major Irrigation Organization. It

- is binding on successful bidder to extend all necessary support in getting the tests done till completion of the work in all respect at his own cost.
24. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative Department of the State Government is allowed to work as a contractor for a period of two years after his retirement from Government service without due permission of the Government.
 25. The bidder shall have to furnish No relation certificate along with the bid documents to the effect that no officer of the Department to the rank of Assistant Engineer or above is related to him.
 26. All bidders are required to submit the details of quarry for procurement while submitting bids.
 27. If L1 bidder does not turn up for agreement after finalization of tender, then he/she shall be debarred in participating in bidding for two years and action will be taken to blacklist the contractor.
 28. If the rate quoted by the SC and ST Category Contractors comes to the rate quoted by the L1 bidder (decimal up to two numbers will be taken for all practical purposes) after availing 10% price preference as per Para 2 of Works Department Resolution No. 27748 dated. 11.10.1977, the tender shall be finalized by the tender accepting authority through a transparent lottery system along with other categories of contractors.
 29. As regards the bidding process in which the tender has been floated before the issue of Works Department Office Memorandum No.173 dt 03.01.2026, the bid shall be finalized as per the earlier provisions in Appendix-IX, Clause 36 of OPWD Code Volume-II.
 30. Before acceptance of tender, the successful bidder will be required to submit a work programme and milestone basing on the financial achievement so as to complete the work within the stipulated time and incase failure on the part of the agency to achieve the milestone, liquidated damage will be imposed.
 31. Office Memorandum File No. 07556900042013 (PtII)-7885/W dated 23.7.2013 will be treated as part of DTCN and instruction to bidder.
 32. Other details can be seen from the bidding document.
 33. The works are very urgent in nature and contractor should draw the agreement after finalization of the tender without any delay.
 34. Goods & Services Tax (GST) will be imposed as applicable.
 35. Any Corrigendum/ Addendum will be displayed in website <http://tendersodisha.gov.in> only. It is the bidder's responsibility to verify the web site for latest information/ corrigendum related to the bid.
 36. If any bidder backs out from the bidding process or make any request for alteration or modification in terms and condition of the bid shall debar the bidder from participating in the online bidding system and his portal registration shall be blocked including recommendation to registering authority for cancellation of his registration as contractor including forfeiture of bid security deposited.
 37. The contractors R.C (Registration certificate), GST/GSTIN, PAN, No Relation Certificate, work not abandoned for last five year & Affidavit, the scanned certified copies of which have been submitted through web-site should be produced in original to respective Divisional Officer for verification within 7 days of issue of **Letter of Acceptance (LoA) by the Divisional Officer (by e-Mail or WhatsApp)** to the successful bidder.
 38. The authority reserves the right to reject any or all the bids without assigning any reason thereof.




