## **Expression of Interest for Empanelment of PORTABLE X-Ray Services**

Interested Agency/vendors with the following pre-requisites are requested to submit "Expression of Interest for" empanelment to provide PORTABLE X-Ray services for Intensified TB Elimination Campaign in Sambalpur District.

- a. X-Rays shall be conducted by qualified Radiographer.
- b. Must have obtained AERB approval from appropriate authority.
- c. Radiologist either available physically or connected remotely to issue report with signature.
- d. Performance Security amounting to Rs.50,000/- in shape of Demand Draft in favour of "ZSS NON NRHM, SAMBALPUR" payable at Sambalpur which will be refunded after completion of the assigned job.

### **Key Conditionality**

1. The private Health Facility having **PORTABLE** X-Ray services may have their establishment in local area under Sambalpur district or in anywhere in Odisha.
2. As and when required, the agency/vendor may have to move to Public Health Institutions with their portable X-Ray machine to provide the services.
3. Maximum rate Rs.250/- including GST is to be paid for chest X-Ray per patient.
4. The payment shall be made to the agency/Vendors (Private facilities), after submission of bills along with X-Ray report duly signed by the Radiologist.
5. The rate of X-Ray services will be valid for 01 year from the date of approval.
6. The agency/vendor must have to submit the valid GST Certificate with PAN of their Institution along with the Expression of Interest.
7. Application will be entertained in a sealed envelope through speed post/courier services and the application should reach in the Office of CDM & PHO, Sambalpur on or before 05:00 PM Dt- 16.06.2026
8. After the scheduled time period no application/bids will be entertained.
9. The bids will be opened on the next day at 11:00 AM on Dt- 17.06.2026 and empanelment will be finalized.
10. The authority reserves the right to cancel the bid without assigning any reason thereof.
11. If any agency/vendor fails to execute the assignment in due time, CDM & PHO, Sambalpur has the right to assign the work of the defaulter agency to another agency assigning any reason thereof.
