UREA/GRANUCAL INSECTICIDE TO REDHAKHOL FOREST DIVISION,
REDHAKHOL, DIST-SAMBALPUR, ODISHA FOR THE YEAR 2026-27**

It has been decided to procure Fertilizer, Liquid Urea and Granular Insecticide of approved quality through sealed tenders. The Reputed Registered Dealer/Manufacturer/Individuals expressing interest shall download the tender application from the website www.redhakholforest.com/www.sambalpur.odisha.gov.in / www.odishaforest.in. The cost of the Tender paper is Rs.6,000/- (Rupees Six Thousand) Only which shall be deposited in shape of Demand Draft drawn in favour of the Divisional Forest Officer, Redhakhol Forest Division payable at Redhakhol while submitting the tender.

The tenderer has to furnish all required documents & rate of the material, taxes separately in the application form. The tenderer has to submit the **Technical Bid and Financial Bid in two separate closed covers. Name of the item should be super scribed on the top of the envelop.**

Eligibility: -

1. The invitation to participate in the Tender Document is open to Reputed Registered Dealer/Manufacturer/Individuals.
2. The Tenderer must not have been banned or blacklisted by any Government organization.
3. There must not be any adverse action pending against the Tenderer.

TERMS & CONDITIONS

01. Offering of best price by firms/suppliers/supply house/manufacturers should be submitted in the Prescribed Form provided in the Tender documents.
02. Sample of the Product should be deposited in the Divisional Forest Officer, Redhakhhol Forest Division with proper acknowledgement. The sample should be deposited at least in 1 KG pack or as per Unit Pack to be supplied.
03. The selected tenderer should supply the Fertilizer, Liquid Urea and Granular Insecticides (expiry date of the supplied items at least one year from the date of supply) within 10 days from the date of placing order.
04. Delivery of the materials should be made in range headquarters of this Division.
05. Damaged, expired and sub-standard materials should be replaced by the tenderer at their own cost.
06. All materials should be supplied as per the sample given and selection thereof, failing which the supply orders will be cancelled automatically, and the bidders shall have no financial claim over the material supplied and need to lift all the materials from the site at their own cost.

07. The rate of materials should be quoted inclusive all taxes and transportation. If transportation cost is mentioned separately, the cost will be considered after adding per KG/Qntl cost. In case transportation cost is not quoted, then the base price quoted will be considered per KG/Qntl including transportation cost as NIL

08. Copy of GST Filed and Income Tax Returns Filed for last three financial years (2023-24,2024-25 & 2025-26) should be accompanied along with the tender documents.

09. Payment will be made through WAMIS/IFMS Soft after receipt of all the materials ordered with checking of quality and quantity of the materials. The payment under WAMIS/IFMS is subject to the availability of funds and the undersigned will not be responsible for any delay in payment due to non-availability of funds.

10. The tenderer should clearly mention the Bank A/c Number, Bank Address and IFSC Code in which the payment will be made. (copy of the Bank Pass Book first page shall be attached with technical Bid)

11. A Firm is allowed to bid for more than one product, if it is dealing with the same.

12. The Tender Documents incomplete in any aspect is liable for rejection.

13. The Tenders received after the scheduled date and time is also liable for rejection.

14. The Price quoted is inclusive of all taxes with site delivery at different Ranges of Redhakhol Forest Division including transportation.
15. The rate of successful bidder may be valid till next tender.
16. All legal disputes shall be subject to the jurisdiction of the Civil Court, Redhakhol only.
17. The Tender will be finalized by the Tender Committee of the Division taking into consideration the price quoted and quality of the Product. Mere quoting lowest price for the product does not entitle a bidder for selection compromising the quality as decided by the Tender committee.
18. The decision of the Tender committee will be final and binding in any stage of the Tender Process.
19. Bid documents consisting of Specifications, the schedule of Quantities and the set of terms and conditions of contract and other necessary documents can be **seen in the website:** www.redhakholforest.com/www.sambalpur.odisha.gov.in / www.odishaforest.in.
20. The bidder shall have to deposit the cost of tender paper @ Rs. 6000/- for participation in the bid in shape of Demand Draft only in favour of Divisional Forest Officer, Redhakhol Forest Division. The cost of tender form is non-refundable in nature.
21. The Successful Bidder(s) shall have to deposit Security Amount @ 3% of the total amount of tender in shape of TDR in favour of the Divisional Forest Officer, Redhakhol Forest Division after finalization of the tender. The amount of Security Deposit is refundable after successful supply of the materials as per the standard of the Tender. Any discrepancies on the process will tantamount to the forfeiture of the Security Amount.
22. The Bid documents will be available in the website www.redhakholforest.com/www.sambalpur.odisha.gov.in / www.odishaforest.in from 02.06.2026-02.00 PM.
23. Bids shall be received "OFFLINE" on or before 19.06.2025 up to 5.00 PM.
24. Bids received shall be opened at 11.00 AM on 20.06.2025 in the Office of undersigned in the presence of the bidders who wish to attend or represented by their authorized representative. Bidders who participate in the bid can witness the opening of bids. If the office happens to be closed for any administrative reason on the last date of opening of the bids as specified the bids will be opened on the next working day at the same time and venue.
25. Bidders are to submit the TECHNICAL BID [Forms A (I), A (II), A (III)] and FINANCIAL BID (Form- B) in a two Separate Sealed Cover quoting price in FINANCIAL BID for the article intend to

supply Planting Materials and both the cover to be enveloped in one Cover and dropped in the Drop Box.

26. The Authority will not be held responsible for any other inconvenience during bidding process.

27. The Addendum/Corrigendum if any will be hosted in the district website only and bidders have to access the same from time to time during the bidding process.

28. The intending bidders are required to furnish their e-mail address and cell phone number to inform them any message relating to the tender.

29. Selection will be made on cost effective basis i.e. lowest price for the same brand.

30. The bidders have to deposit their sample of product with recently obtained test report (the test report/certificate should not be dated earlier than 31 December 2025) of the product from any National/State Govt. Laboratory, to be supplied to the office of the undersigned with proper acknowledgement for quality assurance which will be finalized by the committee after opening of financial bids on another date to be intimated later on to the successful bidders in the technical and financial bids.

31. The bidders/vendors/supplier will have to attend the office of the undersigned on the date intimated later on for checking of quality assurance by the committee.

32. In case any bidder/vendor/supplier is not able to get tender documents online in the District Web Site due to any sort of unforeseen technical fault he/she may obtain the same from Head Clerk of the office of Redhakhol Forest Division on payment of Rs. 6000/- of submission of Bank Draft and submit the same in the Drop Box.

33. The quantity of article will be specified after finalization of the tender depending upon the availability of funds. The purpose of the bid is to empanel a list of bidders for Planting materials for the current financial year 2026-27 to streamline the procurement within the restriction of timeline. The selection of a bidder is subject to change as per the time-to-time guidelines of the Government of Odisha.

34. Once opened, no tenderer will be allowed to withdraw from the tender process till its finalization.

35. Conditional tenders are not accepted and liable for rejection.

36. The rate so quoted will be firm and remain the same during the contract period of one year. No increase in price of any item shall be allowed under any circumstances during the period of contract.

37. The rate offered should be inclusive of all charges and delivery at Ranges of Redhakhhol Forest Division (Per unit cost of Planting materials be quoted inclusive of all taxes as applicable.)
38. Any sub-standard supply will not be accepted and the contract will be liable for termination with forfeiture of Security Deposit for breach of contract at any time without notice.
39. The contractor will be personally held responsible for the quality and quantity of the planting material supplied to the Division.
40. On receipt the supplies will be weighed at the Range Point and any shortage will be treated as non-supply and will be dealt as per the terms and conditions of the tender.
41. The contractor will be responsible to obtain a receipt after weighing of supplies from the official deputed to receive the supplies which will be attached with the bills to be submitted.
42. The supplies/items/articles at any point of time may be inspected by the Forest Officers or his authorized representatives or any officials in presence of concerned store in-charge and they will have the right to reject the supply in case of short supply or if the standard does not meet the specification as per the sample deposited. In case of defective / substandard supplies or in case of non-supply/short supply/delayed supply, the purchase shall be effected by the Divisional Forest Officer, Redhakhhol or his representative from the open market. Any amount so incurred for the said purchase including carriage, transportation etc. will be recovered from the contractor or his security till the new contract is finalized.
43. The Purchase Committee reserves the right to accept or reject the lowest bid without assigning any reason for such acceptance/rejection.
44. The undersigned reserve the right to increase or decrease the volume of any item or to the extent of 25% of financial value or withdraw any items of supply at his discretion at any state of execution of works. The undersigned may extend the supply order at the same price for 6 months.
45. The rejected Planting Materials, if any must be removed within a week of the written or verbal notice.
46. Canvassing in any form whether direct or implied will led to disqualification.
47. Applicable taxes (TDS) as per prevailing rate and rules would be deducted from the bill amount of the suppliers.
48. The authority reserves the right to place order of supply, fully or partly to one or more bidders in respect of Planting Materials where ordered rate is same.

49. In case of any epidemic/pandemic/disaster/any other difficult situation due to which the cost of materials is escalated in the market or any other source, it shall be borne by the bidder. The contractor will ensure the supply of the item as per the terms and conditions of the tender. The contractor will have no claim or any compensation for any loss due to any disaster or inflation or cost escalation during the contract period.

50. All legal disputes shall have jurisdiction to the District of Sambalpur only.
